- Chr. Savin: Is anyone else opposed to HB 767? If not, we will declare the hearing closed.
- HB 1251 AN ACT CONCERNING MUNICIPAL EMPLOYETS, "PROVING FOR RETENTION OF MUNICIPAL EMPLOYEES UNTIL THE AGE OF SEVENTY-THREE".
  - Mr. Keeley, 2nd Taxing Dist., Norwalk: The purpose of this bill is to enable the second taxing district to continue to utilize the services of employees who must terminate employment at 65 or 70. These persons have worked on jobs for many years and have a great deal of training and experience in these jobs. Because of that they become valuable. This bill would make it possible to utilize their services for a three year period with the approval of the governing body of the municipality. I strongly urge passage of this bill. I would like to suggest an addition to the bill "other than policeman or fireman".

Mayor Freese, Norwalk: I am in favor of this bill.

- Mr. Styrin, Norwalk: I am in favor of this bill.
- Chr. Savin: Is anyone else in favor of this bill? Is anyone opposed? If not, we will declare the hearing closed on HB 1251.
- HB 40 PROVIDING FOR A COUNCIL-MANAGER FORM OF GOVERNMENT FOR THE TOWN OF WETHERSFIELD
- Rep. Clark, Wethersfield: I introduced this bill. The town has a population of 15,000 people. Last fall 1350 electors met in town meeting to consider sending this bill to the Legislature. The vote at that meeting was 880 in favor, 470 against. There are two organizations in the town one, The Citizens Charter Committee, is in favor of this form of government. The other is opposed to it. They are both represented here today and you will hear from both sides. I am here in favor of this bill. A resolution was passed at that town meeting stating that the two representatives were to use their best efforts to secure passage of this charter. I would like to ask that the Chairman of our School Board, who has to speak in New Haven today, be allowed to speak.
- Chairman, School Board, Wethersfield: I am here authorized by a vote of the Board of Education at a meeting January 28 to state our position on this proposed charter. This does not represent the individual views, but the board itself. The Board of Education takes issue with the budgetary matters. In this connection action of the town council shall be final insofar as the budget is concerned. I am offering here a motion passed by the Board of Education requesting that this be part of Section 706: The action of the Town Council relative to the budget shall be final, except that, if the total amount requested by the Board of Education is reduced by five per cent or more, the Board of Education may request, and the Town Council must call, a special town meeting within thrity days for the separate consideration of the school budget. The voters present at this meeting shall have the authority to review the action of the Town Council and restore any or all amounts of money not granted by action of the Town Council. Such restoration shall be mandatory on the Town Council. The purpose of that is that we feel a situation might arise as in other towns where cuts are made in the budget. Speaking as an individual, for years I have been on the Board where relations with the board of Finance were harmonious. have always met with them and have had favorable hearings. Anything needed for the schools were granted. We would hate to lose that relationship.
