President, this bill is the result of long and hard study by a bipartisan committee of the Federal and Intergovernmental Commission. I consider it a good bill and I urge its passage.

THE CHAIR:

Are there further remarks? Senator Farmer of the 26th district.

SENATOR FARMER:

Mr. President, this morning we had two visitors from New York State who were in the legislative field, who were here working with a sub-committee of commission on Inter-State cooperation on another matter. They inquired about this bill and one of them expressed the view that this one of the most important pieces of legislation which any legislators could pass. It provides a means of cooperation between town or other agencies of this State and cross other State lines to provide service which otherwise could not be provided. Any person who is interested and has been in this field for sometime realizes that many services go by default to the Federal Government either because the State and the sub-division are not willing or able to undertake them and matters that cross the State line, in too many instances, go to the Federal Government and everyone knows that it costs more and that we have greater and greater concentration of powers in the Federal Government. There are a very few people in Connecticut who look upon this tendency with any degree of pleasure I'm sure. And this is one of those efforts to provide these services without having the Federal Government do it. I hope the bill will pass.

On the interstate level, however, the suggestion is meritorious because twenty-nine Connecticut towns border other states. any of the normal and usual municipal services. It provides requirements which the inter-local agreement must meet. It specifies the means by which disputes are to be settled, the means of financing and which and by which they may be dissolved if that should become necessary. There was no opposition to this bill. Mr. Speaker, this bill sets up uniform administrative, uniform proceedings rather for administrative bodies. These days we have more and more rights, both personal rights and property rights determined by administrative agencies and it was felt desirable that these agencies should have uniform provisions for procedure to protect the rights of the parties involved. The provisions of this particular act are modeled after the model State Administrative Procedures Act, recommended by the National Conference on Uniform Law by the American Bar Association and was also endorsed by the Legislative Council in 1959. I believe it's a good bill and should pass.
