SENATOR CALDWELL:

Mr. President, I move the acceptance of the Committee's Favorable Report and passage of the Bill.

THE CHAIR:

Will you remark?

SENATOR CALDWELL:

Mr. President, this Bill amends section 7-323e of the General Statutes and provides that if no widow or no dependent child or children under eighteen years and no dependent father or mother survive a policeman or a fireman, and he is survived by a beneficiary, designated on a form prescribed by the Retirement Commission, such beneficiary shall receive an amount equal to the deceased's contributions into the Fund, under Section 7-323e, without interest. If no beneficiary survives, his contributions, without interest, shall be paid to his Executor or Administrator, or at the option of the Retirement Commission, in accordance with the terms of Section 45-266. I urge it's passage.

THE CHAIR:

Questions on passage of the Bill. All those in favor, indicate by saying aye. Opposed, nay. Ayes have it. The Bill is passed.

SENATOR CIARLONE:

Thank you. I move we accept, Mr. President, the Joint Committee's Favorable Report and passage of the Bill.

SENATOR CIARLONE:

Mr. President, when a child under fourteen years of age has no parent or guardian, the Court of Probate may appoint a guardian and such guardian has to furnish a Bond. This does not apply to the Welfare Commissioner. It's a good Bill and I urge adoption. I might just correct the Clerk, that that Bill is out of Corrections, Welfare and Humane Institutions.

The Clerk was about to correct - there is an error on the Favorable jacket, which indicates Judicial but the Bill itself is stamped from Corrections, Welfare and Humane Institutions and I will note same.
