THE DEPUTY SPEAKER:

The question is on adoption of resolutions on the Calendar, Nos. 92, 93, 94, 95 and 96. All those in favor will indicate by saying aye. All those opposed? The resolutions are ADOPTED.

MR. PRETE (114th):

Mr. Speaker, while under suspension of the rules, I move for the immediate transmittal of Resolution No. 117, Calendar No. 96, Resolution Congratulating Cromwell High School.

THE DEPUTY SPEAKER:

The question is on suspension for immediate transmittal of Calendar No. 96 only, House Joint Resolution No. 117. Is there objection? Hearing none, the rules are suspended and the matter is transmitted to the Senate forthwith.

MR. PRETE (114th):

Mr. Speaker, it's a very simple bill that allows communities in the State of Connecticut to appoint more than two subregistrars of vital statistics. It's an interesting bill which will provide more convenience for the various communities in this matter. I move its passage.

Question, Mr. Speaker, through you.

THE DEPUTY SPEAKER:

What is your question, sir?

MR. COLLINS (165th):

Mr. Speaker, I'd like to ask the gentleman reporting the bill out, there appears to be in the second section of the bill a provision which is being deleted by which the Registrar could appoint subregistrars with the approval of the Department of Health to accommodate federal or state institutions located in any community. In view of that provision, I know there must be some reason why the change is being requested to allow the appointment of some subregistrars, I'm just wondering, in view of the provision in the top part of the file No. in line 23 through 28 which is being deleted, what the reason for the bill is.

THE DEPUTY SPEAKER:

Through the Chair, the gentleman from the 114th, care to respond?

MR. PRETE (114th):

Yes sir. Through you, Mr. Speaker, the bill simply facilitates

the appointment of extra subregistrars. It applies mainly to the large cities where these non-paid people are sometimes difficult to reach and this bill would allow the appointment of a larger number of subregistrars and thereby make it easier, as a matter of convenience, to reach the various individuals involved.

THE DEPUTY SPEAKER:

Will you remark further? If not, the question is on acceptance and passage. All those in favor will indicate by saying aye. All those opposed? The bill is PASSED.

Calendar No. 68, Substitute for House Bill No. 6496, An Act Concerning Public Inspection of Police Accident Records, File No. 46.

THE CLERK:

CAL. NO. 87. FILE NO. 47. Favorable report of the Joint Standing Committee on Public Health and Safety.

SUBSTITUTE HOUSE BILL NO. 6132. An Act Concerning the Appointment of Sub-registrars of Vital Statistics for Issuance of Burial Permits.

SENATOR PAC:

Mr. President, I move acceptance of the joint committee's favorable report and passage of the bill.

THE CHAIR:

Will you remark?

SENATOR PAC:

This bill would permit the Registrar of Vital Statistics to appoint as many Sub-registrars as he deems necessary for the issuance of Burial Permits. Currently he is limited to two in number although he has the latitude of appointing one for any additional federal institution or state institution in that town. All of these appoint Registrars would have to conform to their regulations guiding the Registrar and I think it is a good bill.

THE CHAIR:

Will you remark further? If not, all those in favor signify by saying, "aye". Opposed, "nay". The ayes have it. The bill is passed.
