By deleting this language it is a greater authority to the Governor and the Attorney General in designating other areas which should be properly construed as limited access highways.

Mr. Speaker, this bill is extremely simple. It permits the Connecticut Funeral Directors' Association to submit a list of three names for the Governor's consideration in making the annual appointment to the Board of Examiners of Embalmers and Funeral Directors. The same procedure applies when the Governor is fulfilling a vacancy on that same board. The Association represents 68% of the embalmers and funeral directors in the State of Connecticut and the submission of these names, the State of Connecticut is the beneficiary of the expertise and the knowledge that these people have insofar as this area is concerned. I urge passage of the bill but I cannot overcome the temptation to say that here is one area where the undertaker doesn't have the last say.
