Therefore, I would respectfully request that it be changed to 15 thousand, since we're on an annual basis, and we find on examination of our budget that funds to operate the Connecticut Building are not included andtherefore I'm appearing here on this bill asking that funds be provided.

- Mr. Bernard Chilecki: Mr. Chairman, my name is Bernard Chilecki, and I'm the director of the Boating Commission. The Boating Commission can't seem to find a home. We've had our bills before this committee, and several others, mainly environmental. I'm speaking on behalf of the boating commission and in favor of HB 6413, AN ACT CONCERNING TOWN MARINE OFFICERS. This act would authorize selectman of a town to appoint a special constable, to be called town marine officers, to enforce the boating laws and if invited by said selectman, the Boating Commission would supervise these special constables when they enforce the boating laws. The reason for this bill is that many towns do not have municipal police departments, and enforcement of the boating laws is on a hit or miss basis. This act would create better enforcement of the boating laws. This act will not require an appropriation. Thank you.

Representative Tudan: You're from the Waterbury area?

Mr. Chilecki: No, I'm the Director of the State Boating Commission.

Representative Tudan: I'm just concerned with a concrete example..

- Mr. Chilecki: Well, many of our small towns, say for example Salisbury, Union, do not have an organized police department, and very poor patrolling. Usually there is good patrolling if the first selectman knows something about boating or is interested in it, but usually if he's interested, we work with his special constable. In other areas the first selectman is not interested. He doesn't see the need for it, and therefore the enforcement is very poor.
