Mr. Feinberg.

- Mr. Feinberg: Mark Feinberg, Managing Director of the Connecticut State Developing Commission. This is a Bill, purely to cover us in being able to provide repairs to the Connecticut Building at Eastern States Exposition. In two eventualities, one..if such funds are not included in our regular budget, and two, if the exposition is not going to move in the next year or two from its present location. If funds are provided in our budget, this will not be necessary. And if the exposition does determine later this year it will move in the near future, of course, we will send no more money to maintain that building.
- Chairman Tudan: Well, this is somewhat of an emergency nature, or is this general the general amount you folks spend for upkeep?
- Mr. Doering: This is the second and third phase of repair money which was developed through an architect and engineering look at the Connecticut building, which has been neglected for many years in terms of deterioration. First phase was completed this past biannium. Now, talk as if it is contingent on two things... one, whether it be in the budget, or whether they leave. If they do leave, I'm sure that in two years time they are not going to get fat. Why don't you wait and see what the government has for you, and probably they have something more that you can get the truth.

Mr. Speaker, I rise to support the bill. Let me give you an example to demonstrate the predicate of this bill. Suppose as is the case we have two women judges now in the State of Connecticut. Suppose one of the woman judges has a husband who has a bad heart, a disability. Suppose he is the one who keeps the house. Suppose, for example, his wife is responsible for maintaining the house financially and he takes care of the housework. I wonder if this is not an appropriate measure to cover that situation or comparable situations.

Mr. Speaker, the bill before us provides that under the Open Space Grant-in-Aid Program that if the land involved is condemned by the municipality its value for the purpose of the state grant will be the amount determined in the condemnation and when the municipality coverts such land to acquire state assistance for other purposes the fair market value of the land be paid by the municipality to the state shall be determined by the Superior Court if the State and the municipality are unable to reach agreement. I urge its passage.

MR. COLLINS: (165th)

Mr. Speaker, question to the gentleman from the 96th on the bill in the file. Through you, would the passage of this bill result in additional funds being expended by the State of Connecticut.

MR. METTLER: (96th)

Mr. Speaker, I believe it is a difficult question to answer. I cannot assume that any additional funds would be required.

I don't think it is a question, Mr. Speaker, of additional monies necessarily being involved in the total. It's a question of clearing up the discrepancy in the law as it presently exists.
