Although again, this may have a salutory effect, it seems to me that if the people within the towns can seek a mandamus action at anytime they wish in order to have a revaluation made under our present law, in some of our towns where properties are turning over rather rapidly, it may be the policy of the town, through its elected or appointed officials, not to do so. The group covered by such insurance consists predominently of employees of such public service company and the solicitation or sale of such insurance shall not be permitted on the public service company property or during their normal working hours of the employees of such a company.
