Mr. Jacobson: Thank you, Mr. Berberick.

Sen. Jackson: Thank you. Ronald Markham.

Mr. Markham: Mr. Chairman, Members of the Committee: My name is Ronald J. Markham and I represent local 218, Steam Fitters Local in Hartford, And I'm here to speak on S.B.#527.

S.B.#527 - AN ACT CONCERNING SUBSTITUTION OF SECURITIES FOR RETAINAGE UNDER CONSTRUCTION CONTRACTS WITH POLITICAL SUBDIVISIONS OF THE STATE.

And I speak in favor of it. I believe it's beneficial to the state. I think there'll be a savings of money involved that will protect the subcontractors who many times are at the mercy of the general contractors and certainly I am not a contractor byt as a journeyman steam fitter I believe if we can protect our subcontractors we also protect our jobs and work goes in more efficiently. The state doesn't have to worry anout litigation as far as the performance of the contracts I think that the performance once the bonds are set that they will perform their work in provision to the contracts and there'll be no problems as far as payment at later date. And Mr. Chairman, will I'm on the floor I'd like to speak on S.B.#528 also.

S.B.#528 - AN ACT CONCNERNING THE PROCEDURE FOR BIDDING ON CONSTRUCTION, ALTERATION, REPAIRS OR ADDITIONS TO STATE REAL ASSETS AND TO REAL ASSETS FINANCED BY STATE FUNDS.

This is a procedure of r bidding on construction and this would pertain to a prefiled bid. When a general contractor goes in with a bid he in turn has the bids from the subcontractors and at a later date an unscrupulous contractor can turn around an say, "well, you gave me a bid of \$100,000 now how much less can you do the job for?" Here the customer gets hurt because the subcontractor has to go back and shave his price to meet the general contractors terms and this in turn hurts the customer because eventhough the job may be efficient may work suitably at the same time at some future date when it comesto maintainence it will mean that certain provisions were not made and therefore, when it comes to taking care of it say, a certain amount of valves were taken out of the system because of they had to cut his price instead of shutting off one unit so you could service it htis would mean shutting down a whole wing. This means more costly maintainence and I would like to report in fair of this bill.

There is an amendment, Senator Finney, which strikes out everything after the enacting clause and changes the substance of the bill, to provide that operators of vending machines in the public buildings of the state, in the State House, here and in the Superior Court Houses, these are blind employees, who would be given the right to buy into the State Retirement system. If the bill is passed.

Now, the original bill that was called first, through an inadvertance the amendment on the bill that was explained first, is the amendment that should go on Calendar No. 793.

SENATOR FINNEY:

I still think it's a great inadvertance. And, if I had, I would like to retain this, if possible.

SENATOR JACKSON:

Well, I respect the wishes of the Senator from the 36th. The only difficulty would be, as far as having Senate Bills go down to the House, as

far as being passed. Perhaps, if we could just have a temporary recess, for a minute, may I try to exaplain the situation to the Senator?

THE CHAIR:

Senator Finney, do you wish a temporary recess, to go over the matter with Senator Jackson?

SENATOR FINNEY:

I'm afraid I understand the situation and I still wish it could be retained.

THE CHAIR:

Do you wish a vote on that, Senator Finney? Do you wish to make a motion and have me put it to a vote?

SENATOR FINNEY:

Yes, I think I would, if you can?

You have a right to do that, Senator Finney.

THE CHAIR:

The question is on a motion, that, Calendar Number 762. File 1084 be passed retaining.

SENATOR CALDWELL:

Is it the intent, I take it this is a Senate Bill, is it the intent that this be passed, till tomorrow retaining?

THE CHAIR:

That's my understanding, when we said passed, retaining.

SENATOR CALDWELL:

My problem is that, of course, it would defeat the Senate Bill.
THE CHAIR:

I'm well aware, Serator Caldwell. If the Chair may exxplain. There are

two bills, here, where the title only is going to used for the substitution of additional legislation on which there is apparently no controversy. The amendment was offered for the first bill, whose title only was to be used, was the amendment that was intended for the next bill on thepage, whose title only was to be used.

So the request of Senator Jackson, we revoked the passage of the bill, the amendment being the bill and he offered the correct amendment to that title. It was an inadvertance, on his part with the amendments before him. And, I believe, that, if we went slowly, through it and explained carefully the amendment, we might obviate the opposition.

SENATOR FINNEY:

Mr. President, if I may, I will withdraw my motion.
THE CHAIR:

Thank you, Senator Finney. Now, can we start all over, Senator Jackson? I think Sentor Finney's point is an excellent one. It's bad enough passing a bill by title only, with a substitution. I don't mean bad but, hard to follow. But, then when the wrong substitution is made, it's almost like the Colts and the Jets. Calendar Number 762, would you start again? SENATOR JACKSON:

Mr. President, I move acceptance of the committee's favorable report and passage of the bill. The Clerk has an amendment. I waive the reading of. THE CHAIR:

If there is no objection, the reading will be waived, but will you explain the amendment?

SENATOR JACKSON:

Mr. President, the purpose of the amendment is to allow the blind em-

ployees of the State Building and the State Court Houses to buy into the State Retirement System and become eligible for retirement benefits. This would be optional on their part, providing they would pay into the State Retirement System.

CAL. NO. 793. File No. 1129. Favorable report of the joint committee on Judiciary. Substitute Senate Bill 1049. An Act Concerning Amendments to the Mechanics Lien Statutes.

SENATOR JACKSON:

Mr. President, I move acceptance of the joint committee's favorable report and passage of the bill. Again, the Clerk has an amendment, which I would waive the reading of.

THE CHAIR:

If there is no objection, the reading will be waived. Will you please explain, I believe, once again, the amendment is a totally substituted bill.
