THE SPEAKER:

You have the request of the gentleman from the 148th for leave of the chamber to summarize in lieu of Clerk's reading. Is there objection? Hearing none, the gentleman from the 148th to summarize.

MR. ABATE (148th):

Thank you Mr. Speaker. This amendment quite simply, ladies and gentlemen, clarifies the fact that it shall be the responsibility of each spouse to support his or her family. I move adoption of the amendment, Mr. Speaker.

THE SPEAKER:

Will you remark further on House "A"? Question is on its adoption. All those in favor of House "A" will indicate by saying aye. Opposed? House "A" is adopted, ruled technical.

Will you remark on the bill as amended?

THE DEPUTY SPEAKER IN THE CHAIR

MR. ABATE (148th):

Yes, Mr. Speaker. If the members of this general assembly were to examine file No. 604, you would see that it is part of the existing statute that both husband and wife shall be liable for the reasonable and necessary services of a physician or dentist and for hospital expenses rendered the husband or wife or their minor child. The language that we have inserted is except if such physician, or dentist or hospital expense is an expense of the last illness of either spouse, only the estate of the deceased spouse shall be liable for such expense unless it is not sufficient therefor. What this is seeking to address is a problem which has arisen regarding deductions on one's federal estate tax return. Individuals, i.e. husbands or wives, who have attempted to claim a deduction for expenses incurred regarding last illness have been denied the deduction simply because our

statutes indicate that it shall be the husband's responsibility to pay for his wife's last illnesses and the wife's responsibility to pay for the husband's last illnesses. This bill addresses that problem and indicates it's the responsibility of the estate. Therefore, if the estate makes the payments, the estate is entitled to the deduction.

I move passage of the bill.
