person outside of his home or business. State law enforcement officials are exempt from this. The Bill would also make clear that sheriffs, parole and police officers from other states who are here on official business, coming to retrieve prisoners or coming for reasons of law enforcement are in fact, exempt when they come into the State and would also specify that Federal Marshalls or law enforcement official agents of the United States government need not have permits in order to carry handguns while on official duty in the State of Connecticut. I'd ask, if there is no objection, that this Bill be placed on the Consent Calendar.
