REPRESENTATIVE LYONS: Thank you. And other members will be joining us shortly. The first individual signed up to speak is Deputy Commissoner O'Dea from the DMV.

EDWIN O'DEA: Senator Owens, Representative Lyons and Members of the Committee; I would like to, on behalf of MVD testify on the following: Senate Bill 1042, An Act Requiring the Inclusion of Odometer Mileage in Records Maintained by Motor Vehicle Lessors.

This bill would amend section 14-153 of the Connecticut General Statutes to include mileage reports on all vehicles leased. Thousands of vehicles are sold by leasing companies yearly. A number of instances have surfaced where the records of the lessors have indicated that motor vehicles that have passed through intermediaries have had their odometers rolled back. While most lessors have cooperated with Motor Vehicle Department investigations, we feel it is in order to protect the consumer, information regarding odometer readings should be required to be kept by lessors and be made available to proper authorities. No fiscal impact to the Motor Vehicle Department.

Senate Bill 1043, the Motor Vehicle Department

SB 10 42 (MVD proposal) A A requiring the inclusion of odometer mileage in records maintained by motor vehicle lessors.

This bill would amend Section 14-153 of the CGS to include mileage reports on all vehicles leased. Thousands of vehicles are sold by leasing companies yearly. A number of instances have surfaced where the records of the lessors have indicated that motor vehicles which have passed through intermediaries have had their odometers rolled back while most lessors have cooperated with MVD investigations, we feel it in order to protect the consumer, information regarding odometer readings should be required to be kept by lessors and be made available to proper authorities. No fiscal impact to MVD.

SB 1043 (MVD proposal) AAC the issuance of special number plates for handicapped persons.

This bill will eliminate the \$20 class transfer fee currently charged to handicapped persons when they transfer from an existing registration to handicapped plates. Bill does retain the \$5 one-time fee for plate production cost.

Fiscal impact to MVD is a \$12,000 loss of revenue.

SB 1045 AA eliminating the safety fee for the issuance of replacement motor vehicle number plates.

Last year, the Legislature passed a bill to require 2 plates on all vehicles with the condimtion that motorists not pay for the plates. Because of amendments passed after the original bill, that section which eliminated the fee charge was inadvertantly changed back. This bill will assure that residents will not be charged a safety fee for their plates.

No revenue loss because it was figured in last years budget not to anticipate collecting the fees.
