Yes, Mr. President. Mr. President, the first portion of this bill is one that we normally adopt every couple of years confirming and ratifying the

General Statues as -- as adopted.

The second portion of this bill, however, would establish a new rule of statutory construction in our statutes which would make it clear that when a statute references another statute of this state, that reference includes any amendments to the referenced statute, unless a contrary intent is clearly expressed in the legislation. Statutes frequently incorporate other statutes by reference rather than repeating the actual language of that other statute, and most readers of those statutes that incorporate other statutes by reference would generally assume that in order to fully understand that statute they would have to make reference to the most recent version of the incorporated statute with any amendments that might have been adopted over the years. But there's a old line of statutory construction cases that occasionally have been invoked where courts have said otherwise, and this legislation would make it clear that the most recent version of the statute would control.

THE CHAIR:

Will you remark further on Senate Bill 1028? Senator Roraback.

SENATOR RORABACK:

Thank you, Mr. President. Through you, if I may, a couple of quick questions to the proponent of the bill.

My understanding is that there's a -- an old common law rule called the "cross-reference cannon" and by virtue of that old common law rule, this -- Connecticut has from time to time said that if a statute incorporates another statute by reference, the reference is made to the incorporated statute at the time the new statute is passed. And through you, Mr. President, to Senator McDonald, my understanding of Section 2 of this bill is that it's going to get rid of the common law cross-reference cannon and instead provide that whenever we incorporate another statute by reference our intention is, for if the reference statute is updated over time, that the statute which makes reference to the other statute will always incorporate the updated referred statute. That's a mouthful, Mr. President, it's kind of a strange --
