REP. GUERRERA: Thank you, Representative Lemar. Any other comments? Thank you for your testimony. It was very helpful.

RICHARD RETTING: Thank you.

REP. GUERRERA: Next, can I have Sergeant Andrew Gallagher. Is he here? And we're honored to have Representative Fox from the Judiciary Committee with us today. We appreciate him being here, obviously you have your own committee going on right now too so.

REP. FOX: Thank you, Mr. Chairman.

ANDREW GALLAGHER: Rather than just reiterate what I've already put in written testimony, I think I can cut to the chase here. The purpose of my bill was to try to get the Department of Motor Vehicle to change their suspension protocol for people who have been charged multiple times of operating without a license. The bill as its written just doesn't address it at all. The titles correct, the language is useless.

HB 5462

If we're going to stay that way, you might as well just tell me to leave now. The bottom line is the reason I came here today was to explain I had an episode where I stopped a gentlemen for operating without a license on another violation. When I pulled up his license history through CIVLS Version One under DMV shows no license found.

When I went back to headquarters because I was trying to diligent I discovered that he actually had a 300 number, which is not a suspension number, but it's a tracking number

assigned by the Department of Motor Vehicles.

In the old days when I started 24 years ago, if you got ticketed for not having a license you got suspended. Motor Vehicle doesn't operate that way anymore. So when I ran this guy's history, he had multiple offenses for operating without license, basically because he could keep mailing in an infraction ticket for operating without a license the Department of Motor Vehicles does not issue a suspension for this person.

If I had run his name and he was under suspension, I would have gotten a suspension date, but because he's never had a license and the Department of Motor Vehicles doesn't suspend him because he keeps mailing in the tickets, there's no suspension found.

REP. GUERRERA: Well, I like that. To the point. Representative Fox.

REP. FOX: Thank you. Thank you, Mr. Chairman and thank you Sergeant Gallagher for -- for being here today. I know we've had an opportunity to discuss this proposal and I recognize that the proposal may need an amendment of sort of substitute language in order to effectuate what the problem you're trying to address. And just so I'm clear and the way I understand it and so everyone else is clear. This does not address those situations where you have a license, but just aren't carrying the license.

ANDREW GALLAGHER: Absolutely not. This is a person who has never had a license before, but if you continue to mail in your infraction ticket and pay the fine, no harm, no fowl in Motor Vehicles Eyes. I'm just trying to say that someone who has multiple, three, four, five offenses for operating without a license,

who continues to mail in a ticket, we need to have that person under suspension. Right now we don't have the ability with our mobile data terminals to determine license histories.

I understand that Version 3.0 of CIVLS with DMV may address that, but we need to do the job more efficiently. We don't have time to sit in patrol car and look up three levels of history and three different option screens. If the person is under suspension because they have multiple violations of not having a license it simplifies it, we cut to the chase, we go right to a misdemeanor summons.

They go to court where there's time to look up their license history to have the oversight to determine why they're under suspension, if they don't have a license, if they have a violation from another state that hasn't been adjudicated properly.

REP. FOX: Thank you, Mr. Chairman and if I may also, be some of the reasons that people need to have a license is because they also often then would not have insurance or other important criteria that we establish for those who want to drive a car on our roads.

ANDREW GALLAGHER: Certainly unlicensed operators have a higher propensity for other violations whether they be just additional registration and insurance requirements, but also people who don't have licenses typically have more of a criminal involvement that they're trying to keep from the police to avoid further detection.

REP. FOX: And if I could just ask one more question? When you determine that someone does not have a license is it the type of situation where they have already committed

some sort of infraction that required them to be pulled over and then at that point, you determined they do not have a license. It's not something you can determine until that -- that point; is that right?

ANDREW GALLAGHER: That's correct. It's not as if no license comes up on a license plate reader or any other way. You have to have a violation, a reason to stop or probable cause and then through your interview and contact with a person you make the determination that they don't have a license.

REP. FOX: Well, thank you again, Sergeant Gallagher for proposing this and for being here today. And thank you, Chairman Guerrero for -- for raising this bill.

REP. GUERRERA: Thank you, just a quick comment and maybe Representative Fox can help clarify some of this. Even though, Sergeant that we can put laws in place and I was just reviewing this with colleague here, what licenses, whatever maybe suspended license or -- or like you said multiple infractions, once it goes to the courts, I mean, then if there's some deal being cut with the prosecutor or whatever maybe, I just feel as though sometimes we can put these in place, but then obviously it gets overturned in the courts.

If we do something now is that your assumption then, Representative Fox, that maybe that then it's clear-cut and there can't be any dealings going on?

REP. FOX: No, I think -- thank you, Mr. Chair. I'll respond to your question. The -- the way I understand it is anybody who gets a ticket -- infraction that -- by which they can mail in a payment of a fine they can also please not

guilty, in which case it would go to the courts. The situation that I believe is being described here is one in which, a person could repeatedly mail in the failure to have a motor vehicle license infraction, and there would be no record of the multiple -- the number of offenses that have taken place.

And I -- I think perhaps what we can do here is say if somebody does -- if somebody is caught in violation of that offense and they do respond with a guilty plea, we could add a suspension to that in which case then when the -- if that individual is pulled over again, it would turn up that that person has a suspended license which would give you further grounds for an investigation.

Am I correct in that, Sergeant Gallagher?

ANDREW GALLAGHER: Yes, Representative Fox. And I'm not saying direct hone in if you have one ticket per operating without a license. If you have a second greater minds than mine will make the decision on what number of tickets there should be, but at some point we have to say that this person has got to go to court and be directed and have the oversight of the State's Attorney or further follow-up with DMV.

REP. FOX: Thank you. Thank you, Mr. Chairman.

REP. GUERRERA: Thank you, Representative Fox. I appreciate -- I know how busy you are with the Judiciary Committee's going on and so forth, but this is obviously a topic that's been across our committee a number of times, Sergeant, so I'm that maybe we can try to clarify this and try to get something out this year for this type of Legislation. Senator

Leone, with a quick question not 20 parts, correct?

SENATOR LEONE: Never 20 parts, Mr. Chairman. Thank you. Welcome, Sergeant. It's a pleasure to have you here to bring up this Legislation and -- and bring it to our attention and -- and you're obviously going after those that have multiple similar infractions that would have most likelihood other infractions that if you were able to arrest them because of this, would prevent those things from occurring.

ANDREW GALLAGHER: Exactly. The problem is that people without the license the way it's presently is written and the way the Department of Motor Vehicles is enforcing they don't get suspensions. You can continue to mail in the fines as many times as you like and that's what I'm looking to address is the fact that after whatever number the committee decides that they would have a suspension and they will be forced to go to court.

SENATOR LEONE: And so without this Legislation it -- we don't even know how many times this is being abused because there is no limit as to how many times this could occur, correct?

ANDREW GALLAGHER: That is correct, yes.

SENATOR LEONE: And -- and I thank you for your quick testimony. We don't -- with your cutting to the chase we did -- would not want you to leave. We're going to be working hard to make sure that you have a tool that can be effective in this regard so I thank you for coming up here to testify.

**H.B. No. 5462 (RAISED) AN ACT CONCERNING DEPARTMENT OF MOTOR
VEHICLE SUSPENSIONS FOR OPERATING WITHOUT A LICENSE OFFENSES**

Good morning Senator Maynard, Representative Guerrera, Senator Boucher, Representative Scribner and other members of the Transportation Committee

I am submitting this testimony to raise concerns regarding H.B. 5462, AN ACT CONCERNING DEPARTMENT OF MOTOR VEHICLE SUSPENSIONS FOR OPERATING WITHOUT A LICENSE OFFENSES.

The stated purpose of this legislation is "to provide law enforcement the ability to determine whether a motor vehicle operator operating without a license is a repeat offender." The actual language of the bill requires the Department of Motor Vehicles (DMV) to adopt regulations in conjunction with the Chief Court Administrator to provide for the ability to report information in the computerized operator history file system regarding repeat violations of subsection (a) of section 14-36 of the general statutes.

Presently, the DMV operator control record contains all violations of an individual, including one who is unlicensed. The record of an unlicensed individual who has more than one offense of operating without a license in a three year period will reflect this status. These records currently are available to any law enforcement agency or department. Access to operator control histories by law enforcement officials varies based upon the systems used by the particular agency or department that is accessing the information. Therefore, the DMV believes that the issue is not the reporting of the information, but rather limitations on systems that law enforcement agencies employ to access the information.

**Testimony of Sergeant Andrew Gallagher of the Stamford Police Department
Before the Transportation Committee on House Bill 5462,
An Act Concerning Department of Motor Vehicle Suspensions
For Operating Without a License Offenses.**

Senator Maynard, Representative Guerrero and members of the Transportation Committee. I would like to thank you for raising H.B. 5462, AN ACT CONCERNING DEPARTMENT OF MOTOR VEHICLE SUSPENSIONS FOR OPERATING WITHOUT A LICENSE OFFENSES.

The bill presented however is flawed in that it does not address the need for the Department of Motor Vehicles to SUSPEND the license status of operators who are charged with subsequent violations of Connecticut General Statute 14-36a. Department of Motor Vehicle regulations do not classify violation of 14-36a, no matter how many violations an operator incurs, as an offense that can lead to a SUSPENSION. Once an operator has been issued a citation for the violation of 14-36a the Department of Motor Vehicle issues a 300 series identification number to track the operator. The operator while identified for tracking purposes does not show a SUSPENDED status.

While most law enforcement officers have access to Mobile Data Terminals in the field the license inquiry will show "No License Found".

Query of the Department of Motor Vehicle 'Operator History' will identify the 300 series license number but does not show a SUSPENSION for operators who have multiple 14-36a violations. At present many Mobile Data Terminals do not support full access to all Department of Motor Vehicle files. Upgrades to Department of Motor Vehicle CIVLS (Connecticut Integrated Vehicle and Licensing System) will be accomplished in the coming years with more access to law enforcement in the field; however the need to SUSPEND operators with multiple 14-36a violations needs to be addressed.

I thank the committee for raising this important legislation and hope that you will consider modifying the proposed legislation to include mandating a SUSPENSION for multiple 14-36a violations.
