REP. ROY: Moving on. Capt. Dan Wood and he'll be followed by J. Dicine and B. Bentley, if they are here.

DAN WOOD: Good evening Chairman Roy, Senator Meyer and ranking members of the committee. Due to time restraints I have included details in the written testimony that was provided to this committee. Again, my name is Capt. Dan Wood. I run a light tackle guide service out of Niantic, Connecticut full-time and I've been doing so for 32 years.

I'm here today to speak in favor of Bill Number 5412. Bill number 5412 is basically a continuation of Public Act Number 10-124, Section 4, in regards to certain vessels registered with marine dealer numbers and their usage. That was two years ago that that bill was passed and in those two years I know of no negative effects of the uses of the marine dealer numbers.

The ability for me to continue, so the dealer registration directly affects me personally and my business because for -- a number of years ago I received a sponsorship with Hydra-Sports boat manufacturers as well as Evinrude outboard motors and on a pro staff program which was very unique in this area.

For the past years I've been working exclusively with the local Hydra-Sports and Evinrude dealer, who is Atlantic Outboard out of Westbrook, Connecticut.

The ability to use the marine dealer registration while I'm on the water is a very unique situation in that on a daily basis I am demonstrating and promote the products of Hydra-Sports Boats Evinrude motors to the potential clients of Atlantic Outboard. The boat is prominently displayed with signage promoting Atlantic Outboard, Evinrude, Hydra-Sports. This is extremely beneficial to Atlantic Outboard as well as the manufacturers because just because of the sheer number of days the boat is on the water.

The program directly corresponds to numerous boat and engine sales throughout the year as well as utilizing the boat in promotional advertising via articles, newspaper clips, websites, personal appearances at boat shows along with sea trials, tournaments and in-house promotions at the dealership.

The boat is also used to field test new products by the manufacturers before they're available to the public. The ability to put time on these products under real-world conditions is extremely valuable to both engine and boat manufacturers.

The importance of the continuation and passage of this bill is paramount to me because, one, it basically allows me to stay in business. Two, it's extremely important for Atlantic Outboard because I continue to generate boat and motor sales. And thirdly, it would allow marine dealers, all marine dealers in the state to capitalize on the unique and

effective marketing tool that has been so successful to Atlantic Outboard -- that it allowed them to achieve the number one dealer status for Evinrude Motors in North America the past five years in a row and also kept them elevated to the top ten Hydra-Sports dealer in the country.

I know of no negative effects of this usage. I believe the intent of the -- the original intent --

TESTIMONY IN SUPPORT OF BILL NO. 5412**An Act Concerning the Operation of Certain Vessels Registered With Marine Dealer Registration Numbers**

My name is Capt. Dan Wood and I have been operating a light tackle fishing guide service since 1980 out of Niantic, Conn. I am the only full-time fishing guide in the state of Connecticut. This is not a supplement to a principal source of income. During the past 32 years I have complied with all Federal, State and local permit and licensing requirements.

Approximately 15 years ago I received a sponsorship with Hydra-Sports boat manufacturer and Evinrude outboard motors on their Pro-Staff programs. Over the past 10 years I have worked exclusively with Atlantic Outboard, the Hydra-Sports and Evinrude dealer in Westbrook, Conn. This is a very unique situation in that on a daily basis I demonstrate and promote the products of Hydra-Sports boats and Evinrude motors to the potential clients of Atlantic Outboard. This program directly corresponds to boat and engine sales throughout the year, as well as utilizing the demo boat in promotional advertising via articles, news clips, web sites and personal appearances at boat shows, along with sea trials and in-house promotions at the dealership. This endorsement is advantageous to product sales, due to the high number of days the boat is on the water, bearing the signage prominently displayed on the boat for Atlantic Outboard, Hydra-Sports and Evinrude.

The inner workings of this agreement are that I run a dealer demo boat that is for sale throughout the season and at the end of the season the boat is sold. I work for Atlantic Outboard on an in-kind basis. In lieu of salary, I am granted use of the boat for the season. As a fishing guide, I do not receive payment for conveying passengers, but am paid for my fishing knowledge and expertise. The boat is for sale at any point during the year. At the end of each season, the purchaser (usually one of my clients or a client that has sea-trialed the boat) receives delivery of the boat. At that time, sales tax and registration fees are paid to the state. The dealer registration is utilized as the boat is not owned by the dealer or the manufacturer, but by a finance company who floor-plans all dealer boats. One of the big selling factors for people to purchase the dealer demo boat is that it is delivered with the full manufacturers' warranties on the boat and motors.

Through this progressive marketing approach, Atlantic Outboard has elevated their sales to be named in the Top 10 Hydra-Sports dealers in the country for the past six years, and more notably, the #1 Evinrude dealer in North America for the past five years, consecutively.

I have been integral in assisting Atlantic Outboard to achieve the numbers of boats and motors sold through the following:

Tournaments

Besides running a dealer demo boat and being so visible on the water, I have also fished a number of tournaments on the local and national levels, always prominently promoting Atlantic Outboard, Hydra-Sports and Evinrude. This offers exposure to these name brands in print articles and through television coverage of such events.

Boat Shows/Sportman's Shows

I assist the dealer in sales and promotion at numerous boat shows throughout the region, lending to their product my endorsement as a well known Captain and leader in the fishing and boating industry.

Personal Appearances

Throughout the year I am requested to make appearances at events held at major venues such as Cabela's and Mohegan Sun as well as in-store promotions at Atlantic Outboard. I take part in seminars at various fishing club organizations. At all events I display and represent Atlantic Outboard, Hydra-Sports and Evinrude.

Media Advertising

On my personal guide business level, the importance of sponsorship support and brand recognition is heavily displayed on

all print, web and social networking promotions. There is not a promotional avenue utilized without my inclusion of Atlantic Outboard, Hydra-Sports and Evinrude, including the lettering on my vehicle which bears the brand logos.

Field Testing

An important part of my relationship and my value to Atlantic Outboard, Hydra-Sports and Evinrude is that I am continuously provided with new, cutting edge products to rigorously field-test before they are available to the consumer market. The feedback they receive from me is invaluable in their product development and enhancement. This enables me to better assist the dealership in future sales with a hands-on working knowledge of the boats and motors.

This program does not deny Connecticut Sales tax collected by registering the vessel I operate, as I hold a Fisherman Tax Exemption Certificate. My business dealings do benefit the State of Connecticut with:

- Numerous boat/engine sales generating sales tax and registration revenues
- My business corporate and income taxes
- Connecticut Charter boat licenses and fees
- Fuel taxes (approx. 3,000 gallons annually)
- Revenue generated by my anglers visiting from in and out of state utilizing local tourist facilities including:
 - hotel accommodations
 - restaurants
 - rental cars
 - auto gas

In late summer 2009, I was contacted by CTDEP Boating Division, alleging potential misuse of marine dealer registration numbers. I received an e-mail which included subsections of the regulations that were current at that time.

I felt I met the criteria of subsection *d*, specifically:

- (1) while a potential purchaser or customer is aboard
- (3) when test running a new vessel after receiving it from the manufacturer
- (6) when test running a trade-in vessel before it is made available for sale
- (7) when running a vessel to, and using a vessel in, a fishing tournament
- (9) when used in connection with the business of the marine dealer
- (11) for personal use of the marine dealer

At this point I contacted State Senator Andrea Stillman's office and through her hard work and diligence, Public Act #10-124, Section 4 was created which clarified regulations governing my unique relationship bridging boat and motor sales with a corporate sponsored endorsement. This was written to be in effect for two years, and will be expiring in May of 2012. Passage of Bill 5412 before you will allow me to remain in business, will enable Atlantic Outboard to maintain the high sales volumes they have achieved, and may open doors for established guides seeking corporate endorsements in the future.

Thank you. I'd just like to deviate for a moment, if I may, because last night I was bringing out a very important piece of legislation and I stumbled in the beginning because I was trying to come up with the list of names that Representative Riley had asked me about.

Madam, for the record, those names are Dasher, Dancer, Prancer, Vixen, Comet, Cupid, Dunder, Blixem. Now I would like to move on to the bill.

Thank you.

The bill is a simple one. It removes a sunset on current legislation which would have sunset at the end

of this month. Under the law, it allows a person to operate a vessel with a marine dealer registration number if he or she has a current U.S. Coast Guard passenger for hire license, holds a current Department of Energy and Environmental Protection, DEEP (inaudible) charter, boatlet registration, and operates a recreational charter fishing guide service using the vessel register with the marine dealer.

I move passage.

DEPUTY SPEAKER KIRKLEY-BEY:

The question before us is on passage.

Will you remark further on the bill?

Representative Shaban, you have the floor, Sir.

REP. SHABAN (135th):

Thank you, Madam Speaker.

Madam Speaker, I also rise in support of the bill before us. As the Chairman indicated, this is similar to something we did, I think, in 2010. This takes the sunset date out. It provides an exemption in very limited circumstances for these individuals who are certainly qualified individuals, top rate under these provisions. And I encourage my colleagues to support it.

Through you, yes, it does, and he also gets additional publicity.

Thank you.

Through you, Madam Speaker, I do not have the details of the agreement, sir.

Well, if the registration number still belongs to the dealer, then I would assume that the dealer still holds title to the vessel. Is that correct, through you, Madam Speaker?

Through you, Madam Speaker, yes, that is true.

I'm just trying to find out if there's some -- if there's some underlying reason why the dealer continues to hold title and has the boat registered in the dealer's name while it's being operated by somebody else.

Thank you. And also, does the dealer whose registration is acceptable for a vessel operated by one of these operators, does that dealer's registration have to be in the state of Connecticut? Through you, Madam Speaker.

DEPUTY SPEAKER KIRKLEY-BEY:

Representative Roy.

REP. ROY (119th):

I believe the registration would be in the state of Connecticut. It's a Connecticut company. It's operated in Connecticut waters.

Through you, Madam Speaker.

DEPUTY SPEAKER KIRKLEY-BEY:

Representative Lavielle.

REP. LAVIELLE (143th):

Thank you, Madam Speaker.

So, in that event, is it common, for example, on Long Island Sound for there to be sort of a cross-pollination of registrations either from New York or from Rhode Island and Connecticut? Is there some intermingling of vessels in those waters, since I'm

I guess that's fine, except that in the meantime time while he's taking people out as passengers and so forth, he has a better part of a profit picture than someone that pays property tax who takes people out on a boat that's registered. And I think it's an unfair competition in the boating industry.

Representative Roy.

REP. ROY (119th):

Thank you.

Through you, Madam Speaker, the owner pays the property tax or fees that are associated with it, and that's going on for I don't know how many years. Department of Motor Vehicles isn't upset. Revenue isn't upset. Things are going well, I think, and we're trying to promote more business.

REP. ROVERO (51st):

While it might give more business, but I think it hurts the tax structure of any town. And I thank you very much for your answers.
