### **STATE LIBRARIAN**

### **Digitization Summit**

Several years ago I articulated a vision for a "virtual branch" of the State Library. Since then a lot of progress has been made. Changes were made to improve our website and work began on a major new website based on an open source content management system called Drupal. The State Library is active on Facebook and Tweeter. Additionally a number of digitization activities have been occurring. Hundreds of images have been placed on Flickr; Ancestory.Com has begun digitizing significant archival collections under an agreement with the State Library; state publications have been digitized and added to the Internet Archive; and digitization projects are being carried out by staff at the State Library. With all of this digitization activity, questions had come up that resulted in my bringing together all of our staff involved in digitization. At the "summit" I articulated the vision and we identified a number of areas of concern as well as suggestions for moving forward. We have begun smaller group conversations around specific areas of concern.

### Budget/Legislation

There will be a full update at the meeting, however a budget was signed into law that restored the delivery service (CCAR) and rolled back much of the cut to (CCARD). During the budget debate the efforts of the State Library to address these two areas of concern to

legislators was noted in both the Senate and House. The budget assumed \$1billion in labor concessions. On Friday, May 6 the Office of Policy and Management released a list of layoffs and budget reduction options for the Governor to consider if he couldn't reach an agreement with the unions. One of the cuts was the elimination of the State Library and all of its services. As you know, we worked with the Connecticut Library Association and may others organizations and individuals to raise awareness of what elimination of the State Library and all Library would mean to the citizens of the state. Late on Friday, May 13, the Governor announced that an agreement still needs to be approved by the rank and file and additional budget cuts will be needed.

The 2010 Governor's Summer Reading Challenge Awards and 2011 Challenge kickoff was held in Memorial Hall on May 6. Governor Malloy, Kendall Wiggin and Harriet Feldlaufer, Chief of the Bureau of Teaching and Learning for the State Department of Education, recognized the 23 winning schools for 2010. More the 135 people attended the event.

### **Professional Activities**

I attended the annual meeting of OCLC's Global Council. My term as a Councilor ends on June 30<sup>th</sup>. I have served on the Council (formerly Members Council) for the past six years. During this time OCLC has grown more international in scope and in governance. The Council was involved in many of the issues related to this transformation and I am proud to have been a part of it.

Ernie DiMattia, President of the Ferguson Library (Stanford) and I presented a program at the Connecticut Library Association's Annual Conference. "Look Before You Leap: Understanding the Library Levy" addressed last year's changes to the library statutes, which allow municipalities to institute a tax to support the library.

Jay Schafer, Director of Libraries, University of Massachusetts, Amherst and I were panelists at the New England Technical Services Librarian's annual spring conference. We provided a "View from the Top: Future Organization and Innovation in Technical Services."

# DIVISION OF LIBRARY DEVELOPMENT

Connection Library Association (CLA) Conference Sharon Brettschneider presented a program with the Association of Connecticut Library Boards on "Library Board Basics" at the conference.

Steve Cauffman, ILL Coordinator, was assistant co-chair of the conference. Among other activities he created a CLA Conference RideShare site, scheduled student volunteers for various tasks at the conference, coordinated the Technology Petting Zoo with Ben Shum and Kate Sheehan and coordinated four sessions on behalf of the Resource Sharing Section. He also presented Keeping Current in ILL.

Mary Engels, Director of the Middletown Library Service Center helped organize several programs: What's Reasonable? ADA Accommodations and your Library (sponsored by the ADA Committee), It's not All About the Money – Raising the Awareness of your Library in the Community (sponsored by the Friends of CT Libraries), Marketing 2.0 (sponsored by the Public Libraries Section), and the Public Relations Awards (presented by the CLA Publicity Committee).

#### Connecticut Book Festival

The first Connecticut Book Festival was held at the University of Connecticut Greater Hartford Campus on May 21 and May 22. It was featured in a lead article in the Hartford Courant Arts section on May 15th. Sharon Brettschneider appeared on a segment of the Fox 61 morning news show with author Matthew Dicks on May 12th. Over 33 authors made presentations and autographed books. In addition there were several performances, including one by DancEnlight and a Connecticut Troubadours mini showcase. The State Library partnered with Connecticut Center for the Book at the Hartford Public Library, Connecticut Humanities Council, Connecticut Commission on Culture and Tourism, Thomas J. Dodd Research Center, UConn Co-op Bookstore, University of Connecticut Greater Hartford Campus and University of Connecticut Libraries. Sharon Brettschneider and Mary Engels were members of the organizing committee.

Mary Louise Jensen, Public Library Construction Consultant, visited Brainerd Memorial Library in Haddam on April 28th to review their project so that they could receive their final construction grant payment. She also visited Chester Public Library on April 28th to discuss planning for a construction project and met on April 29th at the Hartford Public Library to review construction grant paperwork for the Dwight (Parkville) Branch Library.

Douglas Lord, LSTA Coordinator, managed the LSTA grant process for FY 2011-12. These grants were submitted in early March. Each was reviewed by three staff members, and discussed at a Division wide meeting on April 29th. The winning grants are included in your packet for approval.

Douglas Lord chaired the May 9th meeting of the Services to Older Adults Roundtable meeting at the New England Assistive Technology (NEAT) Resource & Education Marketplace.

Public libraries are now reporting all their Connecticard loans on a new web-based report form created for us by Baker & Taylor's Bibliostat. This replaces an old in-house web report form that was hard to use and posed problems with network security. The Division also uses Bibliostat for the public library Annual Report survey. The new survey will be ready for libraries on July 1.

### Children's Services

Susan Cormier, Children's Consultant and Director of the Willimantic Library Service Center, was asked to serve on the Connecticut's Striving Readers Comprehensive Literacy Advisory Committee. The Advisory Committee will play an important role in developing an application for federal funds to support literacy development for birth through Grade 12, but most importantly, in supporting all of Connecticut's learners to become fully literate and prepared for college, work and life. She submitted comments on the draft Striving Readers Plan. Susan Cormier is also working with the State Treasurer's Office to publicize the Connecticut Higher Education Trust's (CHET) Destination Summer Reading program. The campaign urges parents to set up a CHET account for their child and links a child's participation in a public library summer reading program with a chance to win a \$1,000 CHET account. The State Library has begun offering online summer reading programming support through Page Turner Adventures, a pair of performers who specialize in literacy related programming. They have created 6 hours of training, available in short segments (5-10 minutes each). These can be viewed anytime and as often as needed. Three hours covers children and three hours covers young adults. Susan Cormier negotiated an arrangement

that allows access for every public library in the state. Thus far, over 80 libraries are registered to use these materials.

Linda Williams, Children's and YA Consultant attended the Collaborative Summer Library Program (CSLP) annual meeting in Scottsdale, Arizona on April 6-8. Participation in this working meeting is mandatory for participation in the Collaborative. Linda is on the YA Summer Reading Manual Committee and the Vendor Committee whose charge is to weigh in on the process of developing posters and clipart for the summer reading program. Linda compiled booklists to go with the "One World, Many Stories" 2011 summer reading theme. On April 1, Susan Cormier presented a workshop Using 'The Early Literacy Kit' to Communicate the Value of Your Storytime. The workshop reviews the three major research strands that impact thinking about early literacy (literacy research, brain development research and child development research), examined the conclusions of three national literacy panels and the Connecticut Preschool Curriculum Framework, and had participants practice communicating with parents, using developmental tip cards from The Early Literacy Kit: A Handbook and Tip Cards by Betsy Diamant-Cohen and Saroj Nadkarni Ghoting. Each participant received a copy of the Kit.

Linda Williams was asked to be a guest at the Newbie Roundtable in Plainville on March 21, along with two other librarians. She was asked to talk about her job and answer roundtable attendees' questions. Linda also attended the Northwest Directors' Roundtable meeting in Norfolk on April 21 to participate in a discussion on teen behavior in the library and how to attract teen patrons.

### **iCONN**

The April iCONN Times is available at http://www.iconn.org/iConnTimes.aspx If the iCONN budget remains the same as passed by the legislature and signed by the Governor we will be able to restore two databases that had been cut two years ago, the ProQuest National Newspapers and CINAHL Full Text. This was the recommendation of the Connecticut Digital Library Advisory Board (CDLAB) Database Committee and was subsequently endorsed by the Council of Connecticut Academic Library Directors.

Gail Hurley, Statewide Database Coordinator and coordinator of the CT Treasures digitization projects reports that they have now completed uploads of 157 Civil War era newspapers including the Soldiers' Record. Over 30 public libraries have had images added to the Treasures of Connecticut site, which can be found at: http://cslib.cdmhost.com/ctlibs/home.php

Gail Hurley conducted two sessions of reQuest Searching, Administration, and Cataloging training for Acton Library staff in Old Saybrook on May 12.

# Space/Collections

We continue to submit Connecticut Documents to the Internet Archive, such as <u>Report of</u> <u>the Commission on Child Welfare to the Governor. Street Trading Among Connecticut</u> <u>Grammar School Children, 1921.</u>

Ancestry.com staff have restarted their project of scanning the 1917 Military Census along with other material from the Archives after the person working on the project accepted a new position and a replacement was hired.

Nancy Lieffort worked with Barbara Austen of the Connecticut Historical Society to acquire 40 boxes of historical legislative and Connecticut State agency reports that they deaccessioned from their collection. We are sorting and evaluating their condition and adding to the collection as needed.

Students from Hartford area schools researched biographies of Connecticut African Americans at the Library for a special project

Nancy Lieffort, Jenny Groome, and Lindsay Young along with other staff assisted 18 teens from the Region 15 school district researching their History Day topics.

# STATE ARCHIVES

In honor of its 90th Anniversary and Women's History Month, the League of Women Voters of Connecticut (LWVCT) presented the "little black book" of legislative interviews to the Connecticut State Archives at a reception in Memorial Hall on Wednesday, March 23<sup>rd</sup>. In early 1918, Mrs. R. Gladys Bragdon conducted interviews with prominent Connecticut men both in and outside of state and local government. Bragdon interviewed approximately 129 men and recorded in a small black notebook. LWVCT President Cheryl Dunson presented this "suffrage gem" to State Librarian Kendall Wiggin who accepted it on behalf of the State Library and State Archives. Secretary of the State Denise Merrill was the featured speaker. The well attended event was covered by CTN and garnered a lot of news coverage. # LIBRARY FOR THE BLIND AND PHYSICALLY HANDICAPPED (LBPH)

Frank Kurt Cylke has retired as director of the National Library Service for the Blind and Physically Handicapped. Ruth Scoville is acting director while a national search is progressing.

Digital machine shipments have stopped. Libraries are working with NLS to now find a central location for placement of the over abundance of machines that the libraries do not currently need and are unable to store comfortably, including LBPH. A random survey of LBPH patrons was done by phone by a library volunteer. Reviewing the results quickly showed very positive feedback. Doug Lord is analyzing the responses. Patrons who have not yet requested or received a new digital player are being contacted by a library volunteer to tell them about it. If they express a desire to try a digital player, arrangements are then ade to have one sent along with some sample digital books recommended by reader advisors . This will be an ongoing project for several more months.
