### STATE LIBRARIAN

Broad Band Technology Opportunities Program (BTOP) Grant – The Department of Information Technology received a nearly \$94 million BTOP grant to fund the installation of a fiber network to connect emergency services statewide and to bring fiber connections to additional libraries and schools on the Connecticut Education Network. The funds, which are part of the 2009 American Recovery and Reinvestment Act, will also help "refresh" some of the network components which will improve the networks reliability and performance. 26 libraries, the LION automated network and the two Library Service Centers will be getting fiber optic connections. The expansion of fiber into communities where it is not currently available will make it easier to connect libraries not currently on the fiber in the future. I participated in the press conference which included Congresswoman DeLauro, Congressmen Larson, Courtney and Murphy. Assistant Secretary Lawrence E. Strickling, U.S. Assistant Secretary of Commerce for Communications and Information also attended. All spoke to the importance of broad band access in libraries.

## 100<sup>th</sup> Anniversary

The date for the commemoration has been changed to Tuesday, November 30. A reception with "heavy" hors d'oeuvres is being planned for 5:30 to 8:30p.m. in Memorial Hall. Planning is going well for a variety of exhibits that will be placed around the building to showcase the construction of the building as well as significant events that have taken place here. The exhibits will be in place for the week. The Fall issue of the Connector will feature articles about the building. We will also be contributing an article about the building for the journal of the Supreme Court Historical Society.

## Third Thursday Lecture Series

Noted attorney and Connecticut Constitutional scholar Wesley Horton opened the 2010-2011 Third Thursday Lecture series with a talk on the significance of the state Constitution, its history and differences between it and the US Constitution. The series continues on October 21, with historical consultant Robert Laughlin speaking on the witch trials and medicine in 17<sup>th</sup> Century Connecticut.

## DIVISION OF LIBRARY DEVELOPMENT Training

Douglas Lord, LSTA Coordinator, conducted three webinars for the accelerated round of Community Needs Assessment Library Service and Technology Act (LSTA) grants that are being offered. These additional grants are being made available because funding remained from our earlier grant round. These smaller grants are intended to provide planning assistance to libraries in preparation for submission of regular program grants in March.

Gail Hurley and Stephen Cauffman, iCONN, conducted reQuest catalog and Interlibrary loan training for the staff of the Williams School in New London on August 23<sup>rd</sup>.

Linda Williams and Susan Cormier provided a half day workshop on collection development for media specialists in Hamden on September 1<sup>st</sup>. The Division of Library Development and the Connecticut Department of Labor (DOL) will be presenting *Connecticut Jobs Conference: Your Library as a Community Resource for Economic Recovery* on October 15th at the Wallingford Public Library. As high unemployment continues in Connecticut, public libraries are being challenged to respond to the needs of job seekers by offering a variety of services. This program will provide support to libraries' efforts to meet the urgent demands of their communities as they struggle with the loss of jobs and the needs of the unemployed. Attendees will: learn about successful programs at other Connecticut libraries, become familiar with job search resources available from the CT Department of Labor, understand the important role of developing partnerships to support the work of the library in helping their

communities, learn about the resources that are available to help libraries share information regarding workforce programming, network with other libraries developing programs for the unemployed, and learn how to connect with their local workforce system and local DOL offices that provide employment services. This workshop will be followed by regional partnership meetings between libraries and regional workforce offices.

Sharon Brettschneider presented a program on Board roles and responsibilities to a joint meeting of the Bill Memorial, Mystic and Noank and Groton Public Libraries on September 22<sup>nd</sup>.

Linda compiled and designed the brochures, book marks and posters on Children's books set in Connecticut, historic literary landmarks in CT and Connecticut Inventions.

On August 13, several Division staff, spent the day at Chaplin Public Library helping this small library with only one staff person prepare to get their collection online.

### **iCONN**

The Gale database *What Do I Read Next?* has been transitioned to the more robust *Books & Authors*. This new database is designed to complement the browsing habits of today's Web user, integrating easy-to-follow menus that allow users to broaden and narrow their searches according to author, title, series, awards and other criteria. An "if you like" search connects readers to themes and genres that may have otherwise gone unnoticed. Check it out through <a href="www.iconn.org">www.iconn.org</a>. After you are logged in, click on "Select Individual Resources" then on "Books and Authors."

Susan Cormier, Children's Consultant, has partnered with the Connecticut Higher Education Trust (CHET) and the Office of the Treasurer Department with a *Dive into Savings for College* promotion tied to the summer reading campaign. Children enter to win one of four \$1,000 prizes by participating in the summer reading program at their library. The winners' public libraries will each receive a \$500 check. An award

ceremony for the winners will take place at the State Library on Saturday, September 25<sup>th</sup> from 10:30 to noon.

## Read to Grow/Library partnership

The State Library has partnered with four public libraries (Manchester, South Windsor, Rockville and East Hartford) and staff from *Read to Grow* to pilot a program that will try to get families with newborns visited by *Read to Grow* volunteers in the hospital and agree to be contacted by their local public library. This is a natural partnership to connect with families that receive a donated book when their child is born in order to promote a life-long source of books for their children.

# ACCESS SERVICES Space/Collections

- Steve Mirsky inventoried all the copies the library owns of CT State Statutes back to the early 1800s. We are currently moving at least one set of each year to a fireproof vault. Many thanks to Cataloging staff for updating the records in CONSULS and relabeling the items.

Lizette gave a slide presentation on September 8 for 5<sup>th</sup> through 8<sup>th</sup> graders at St. Matthew School in Forestville, discussing records and other items from the State Library collection used to develop the William Webb presentation. She also discussed the transfer of the records from the Military Department to the State Archives in 1988. This presentation followed Kevin Johnson's performance to the students.

   She attended the State Library Disaster Planning Committee meeting on August 26 to finalize evacuation plans for the various State Library facilities.

  Hartford Marriott. The Institute provided the state instructional team, which
  includes Peggy Zabawar from the Department of Administrative Services and
  James Grochowski from the Department of Information Technologies, an
  opportunity to teach a mock webinar as well as learn how to effectively present
  webinars. The team expects to present the two four-week webinars in early 2011.

### **Committees and Additional Staff Activities**

- Lizette attended the joint SAA/NAGARA/CoSA annual meeting, August 11-15, in Washington, DC in her position as Deputy Coordinator of the State Historical Records Advisory Board (SHRAB). She presented a poster on the SHRAB's activities since its inception in 1976 and attended a number of useful sessions on electronic records management.
- Jeff attended a training session on legal research conducted by the Connecticut Judicial Branch at the State Library on August 30.
- LeAnn, Lizette and Kathy attended the third meeting of the Real Property
  Electronic Recording Committee on September 13, chaired by State Librarian
  Ken Wiggin. The committee heard two presentations regarding e-recording and
  conveyance taxes and reviewed an initial draft of the proposed regulations.

## STATE ARCHIVES October is Connecticut Archives Month!

For several years the Archives profession has celebrated October as Archives Month, during which the public is encouraged to think of the importance of archives and manuscripts and the work done by professional archivists. In the past, the State Historical Records Advisory Board has obtained an official statement from the Governor designating October as Connecticut Archives Month. Under a grant to the State Library on behalf of the State Historical Records Advisory Board, the State Archivist, who chairs the board, used federal money to design and print copies of an attractive poster. The main attraction is a drawing of the east front elevation of the State Capitol from the Upjohn plans. The message of the poster is: "Discover the blueprint of your history in Connecticut's Archives!" Copies have been mailed out to public and academic libraries, town clerks, and local historical organizations for posting in public places to publicize Archives Month. Copies will also be given to teachers for their classes on trips to visit the Capitol and State Library.

### Rare Civil War Scrapbook Donated.

Jean Hatfield-Moore donated to the State Archives a scrapbook compiled by her great grandfather Major Samuel Proal Hatfield who served in the First Connecticut Heavy Artillery during the Civil War. Major Hatfield used maps and "Brady" photographs to document the campaigns in which the First was involved. Images appear with informative labels identifying people in the images or placing the picture within context of the war. According to the State Archivist Mark Jones, "The scrapbook is in good shape, and the photographs are not falling off the pages." This is a rare gift and may contain images not seen before. In her letter of donation, Hatfield-Moore wrote that the family was "very pleased that people who have studied the Civil War and still appreciate the sacrifices from the veterans of that war will have the opportunity to see it."
