Sarah THOMSON-KINNEY COLLECTION 1728-1923

Introduction

Sara Thomson was born April 21, 1842. Her parents were Dr. Charles Steele Thomson (1801-1890), who graduated from Yale University Medical School in 1822, and Susan Coit Belcher (1809-1890), daughter of Colonel William Belcher of the War of 1812 and granddaughter of Captain William Belcher who served during the Revolution. Dr. Thomson practiced medicine in Fair Haven, Connecticut, for over 50 years. He and his wife are buried in Fair Haven Union Cemetery, New Haven, Connecticut.

On March 7, 1867, Sara Thomson married John Coddington Kinney (1839-1891) who fought during the Civil War under Farragut at the Battle of Mobile Bay on the frigate Hartford. John Kinney, son of Rev. Ezra Denison Kinney, graduated from Yale in 1861. By profession he was a journalist and worked for the Waterbury American and the Hartford Courant where he was editor from 1872 to 1890, when he was Adams postmaster in Hartford. He belonged to many military and other associations. In 1882 he was elected Major of the First Company, Governor's Foot Guard, and was U.S. Marshal from 1882 to 1886. As editor of the Courant he took an active part in public affairs and was considered an authority on the political history of the state.

Sara Thomson Kinney was a leader in many organizations. Of special concern to her was the plight of the American Indian. For over thirty years she was president of the Connecticut Indian Association, which was organized in 1881 and incorporated in 1887. Its aims were to influence the people by circulating knowledge of the status of Indians, to influence the government to execute laws and fulfill treaties, and to aid Indians in civilization, education, self-support, citizenship, and Christianization. In 1884 the organization aided Philip Stabler, a young Omaha Indian, and his wife to build a cottage for their own use on the reservation. Donations of clothing and household articles were also sent. began support for a home-building plan, because it was felt that in order to continue civilized habits, Indian graduates of training schools must not return to their old ways when they went back to the reservations. In May 1886 the Association supported the education of Susan LaFlesche, an Omaha Indian girl and graduate of Hampton Institute, who wanted to become a physician and teacher among her own people. In 1888 it was voted to undertake a practical farming program for Indians. Also that year the missionary station at Fort Hall, Idaho, was formally adopted as special charge of the Connecticut Indian Association, and Hartford Hospital agreed to receive two Indian girls into its training school for nurses.

Sara Thomson Kinney was very interested in genealogical research and was connected with many organizations such as the Connecticut Societies of the Colonial Dames of America, United Daughters of 1812, Daughters of Founders and Patriots, and Society of Mayflower Descendants. During a long and active career with the Daughters of the American Revolution, Mrs. Kinney became its State Regent in 1895. She helped to acquire the Ellsworth Homestead for the state organization and was

founder and president of the Ellsworth Memorial Association from 1903-1922. work of the American Red Cross interested her, and during the Spanish-American War and World War I, she and the women in her DAR Chapters engaged in relief work.

She was appointed to commissions by several governors. Her last public work was her service on a special committee created by the State Chamber of Commerce to investigate the possibility of getting the federal government to send to Connecticut waters the old flagship Hartford rotting in the mud of the harbor at Charlestown, South Carolina.

Sara Thomson Kinney died December 14, 1922. Both she and her husband are buried in Cedar Hill Cemetery, Hartford, Connecticut.

This collection appears to have been gathered by Mrs. Kinney at her home on Winthrop Street in Hartford, Connecticut. It includes earlier materials collected by her mother, Mrs. Susan Belcher Thomson of Fair Haven, Connecticut, and by Professor John Stuart Blackie of the University of Edinburgh. The collection includes albums or scrapbooks of letters and autographs of prominent people; records of the Connecticut Indian Association; materials pertaining to Sara Kinney's activities in various organizations; John C. Kinney's letters and papers; family records and assorted genealogical information; printed publications; memorabilia; and photographs. The collection presumably came to the Connecticut State Library sometime after Mrs. Kinney's death in 1922.


