

HENRY L. GOODWIN COLLECTION, 1855-1899

Henry Leavitt Goodwin, a native of Litchfield, was born on Nov. 25, 1821. His father, Oliver Goodwin, was a member of the firm of Hudson and Goodwin, at one time owners and publishers of the Hartford Courant.

Henry started in business life as a bookkeeper for his uncle in Brooklyn, New York. Soon after the discovery of gold in California, he was one of the pioneers who left for the region in 1849. He was not interested in the mining aspect of gold, but the business opportunities that would present themselves in such a climate. For a while he was engaged in carrying letters from one camp to another, but was stopped from profiting by this business by the government. The Penny Post Co., as he called his enterprise, was formed in protest to the manner in which the mail was handled at the San Francisco post office. From the years 1854 to approximately 1859, Goodwin became involved in a publicized campaign against the post master of the San Francisco post office. After the post office dispute, Goodwin met with success in a system of water supply for the miners.

In 1862, Goodwin came to East Hartford. He married Susan Goodwin, the sister of George Goodwin in 1873. She died in less than a year, leaving no children.

While residing in East Hartford, Goodwin did not engage in any business, but continued his actions as a public-spirited citizen, becoming involved in the affairs of the town. He was never slow in pointing out any action which he considered dishonest. His interest in the affairs of the bridge commission, the postal system and the New York, New Haven and Hartford Railroad, led to reforms and disclosures of illegal practices.

The following records consist mainly of newspaper clipping and handwritten accounts of personal and court action in the San Francisco post office dispute, and newspaper clippings and legislative action dealing with the N.Y., N.H. & H. Railroad. Total footage: 1 ft. 3 inches.
